### For Question 1

Each candidate will require

- (a) one 25 cm<sup>3</sup> or 50 cm<sup>3</sup> measuring cylinder
- (b) one 50 cm<sup>3</sup> burette
- (c) one 250 cm<sup>3</sup> conical flask
- (d) two 0.3 g samples of potassium hydrogen carbonate, KHCO<sub>3</sub>, each labelled **0.3 g potassium** hydrogen carbonate
- (e) 100 cm<sup>3</sup> of hydrochloric acid of concentration 0.10 mol/dm<sup>3</sup>, labelled solution F
- (f) 100 cm<sup>3</sup> of hydrochloric acid of concentration 0.30 mol/dm<sup>3</sup>, labelled solution G
- (g) access to water and distilled water
- (h) methyl orange indicator
- (i) a white tile

## For Question 2

Each candidate will require

- [N][H] (a) 0.3 g of copper ethanoate,  $(CH_3COO)_2Cu.H_2O$ , labelled solid H
- [H] (b) 0.5 g of calcium ethanoate,  $(CH_3COO)_2Ca$ , labelled solid I
  - (c) access to water and distilled water
  - (d) splints
  - (e) rack of test-tubes and one stopper
  - (f) test-tube holder
  - (g) Bunsen burner and matches
  - (h) aqueous hydrochloric acid of concentration 1 mol/dm<sup>3</sup>
- [C] (i) aqueous nitric acid of concentration 1 mol/dm<sup>3</sup>
- [C] (j) aqueous sodium hydroxide of concentration 1 mol/dm<sup>3</sup>
  - (k) aqueous ammonia of concentration 1 mol/dm<sup>3</sup>
  - (I) spatulas
  - (m) teat pipettes
  - (n) stirring rod

Labels do not need to include concentrations.
