**Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

**GENERIC MARKING PRINCIPLE 1:**

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

**GENERIC MARKING PRINCIPLE 2:**

Marks awarded are always **whole marks** (not half marks, or other fractions).

**GENERIC MARKING PRINCIPLE 3:**

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit is given for valid answers which go beyond the scope of the syllabus and mark scheme, referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

**GENERIC MARKING PRINCIPLE 4:**

Rules must be applied consistently e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

**GENERIC MARKING PRINCIPLE 5:**

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however, the use of the full mark range may be limited according to the quality of the candidate responses seen).

**GENERIC MARKING PRINCIPLE 6:**

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

1	<p>Responses <i>might</i> use the following ideas:</p> <p><b>A1: Describe your first impressions of the new students based on the introductions they gave while in the circle</b></p> <ul style="list-style-type: none"> <li>• <b>mixed group</b> (det. adults of differing ages, different personalities, class size of 10) [dev. likely to be a challenge to teach]</li> <li>• <b>similarities between Stan and Robin</b> (det. both found the introduction activity difficult) [dev. could get on well/encourage each other]</li> <li>• <b>Robin</b> lacks confidence/shy (det. thin, young man; mutters) [dev. might be intimidated by the situation, might not last the course]</li> <li>• <b>Myfanwy/Miss Roberts</b> is confident (det. beaming smile) [dev. 2	<p>This question tests Reading Objective <b>R4</b> (10 marks):</p> <p><b>R4</b> demonstrate understanding of how writers achieve effects.</p> <hr/> <p><b>Re-read the descriptions of:</b></p> <p><b>(a)</b> Stan’s memories of his school classroom in paragraph 4, beginning ‘A stern face ...’</p> <p><b>(b)</b> what happened at break-time in paragraph 16, beginning ‘Suddenly a teapot ...’</p> <p>Select <b>four</b> powerful words or phrases from each paragraph. Your choices should include imagery. Explain how each word or phrase selected is used effectively in the context.</p> <p>Write about 200 to 300 words.</p> <p><b><u>Up to 10 marks are available for the content of your answer.</u></b></p> <hr/> <p><b>General notes</b></p> <p>This question is marked for understanding of ways in which the language used is effective. Relevant selections from each paragraph are listed on pages 10 and 11.</p> <p>The notes on pages 10 and 11 are a guide to what good responses might say about the selections, along with possible overviews which may be offered for each paragraph. Alternative acceptable explanations should be credited.</p> <p>Candidates can make any sensible comment, but only credit those that are relevant to the correct meanings of the words in the context.</p> <p>Credit comments on effects created by non-vocabulary choices such as grammar/syntax and punctuation devices. These must be additional to comments on vocabulary.</p> <p>Mark holistically for the overall quality of the response, not for the number of words chosen for discussion, bearing in mind that there should be a range of choices to demonstrate an understanding of how language works for the higher bands, and that this should include the ability to explain images.</p>	10

2(a)	<p><b>Stan’s memories of his school classroom in paragraph 4, beginning ‘A stern face ...’</b></p> <p><i>The general effect is that Stan remembers the shame of his failure to succeed in English when younger.</i></p> <ul style="list-style-type: none"> <li>• <b>stern face presiding over ranks of desks (image):</b> remembers the serious expression of teacher, authoritarian, military leader, rows of soldiers, power, control, stifling creativity, Stan’s fear/vulnerability</li> <li>• <b>pulled (young Stan) to attention:</b> got his complete and total focus, military command, suggesting speed with which Stan reacts</li> <li>• (completely) <b>obliterate:</b> annihilate, utterly destroy, Stan’s terror.</li> <li>• <b>unworthy existence:</b> doesn’t deserve to live, little merit</li> <li>• (like) <b>an army cadet’s besmirched tunic buttons (image):</b> ashamed of poor results, unfit for military parade, exposed to the derision of others and/or anger of his elders/superiors</li> <li>• <b>emblematic (of deep failure and shame):</b> signalling his lack of success for all to see, symbol of disgrace</li> <li>• <b>underline:</b> emphasises, drawing attention to, shows up his error</li> <li>• <b>demotion to an even lesser division (image):</b> relegate, he will be dropped to a lower class/position; draws attention to his shame</li> <li>• <b>contorted:</b> twisted (in an ugly way); malice, derision, cruelty of former teacher</li> <li>• <b>triumphant smirk:</b> victorious, smug smile, teacher takes pleasure in Stan’s lack of success</li> <li>• <b>poured over him like hot coals (image):</b> words caused emotional anguish, physical burning pain, causes deep scarring</li> </ul>	
2(b)	<p><b>What happened at break-time in paragraph 16, beginning ‘Suddenly a teapot ...’</b></p> <p><i>The general effect is of an overly dramatic and/or humorous reaction to a relatively minor incident.</i></p> <ul style="list-style-type: none"> <li>• <b>(performed a) rebellious leap (image):</b> Robin has dropped the teapot, disobedience of inanimate object, resisting Robin’s authority over it, nervous</li> <li>• <b>crash-landed:</b> fell forcefully, emergency landing, teapot smashed</li> <li>• <b>(all looked on) horrified:</b> extremely shocked, aghast, alarmed, witnesses at the scene</li> <li>• <b>pumped heavily:</b> great spurts, gushed, (exaggerated) huge volume and force of liquid</li> <li>• <b>shrieked:</b> piercing high-pitched sound, expression of pain, terror, melodramatic</li> <li>• <b>gaping-mouthed (spout):</b> astonished expression, shocked</li> <li>• <b>danced dejectedly:</b> dispirited, jigging about, agitated, useless</li> <li>• <b>proffering paper towels:</b> hold out for acceptance, peace offering, meek attempt to make amends, hopeless efforts</li> <li>• <b>abject apologies:</b> saying sorry, heartfelt expressions of regret, humiliated</li> <li>• <b>asked calmly:</b> unruffled, unshaken, composed.</li> </ul>
