Instructions for preparing apparatus

These instructions give details of the apparatus required by each candidate for each experiment in this paper. A summary of the questions that will be presented to the candidates is included, where appropriate, to allow the biology teacher to test the apparatus appropriately. **No access to the Question Paper is permitted in advance of the examination.**

Candidates must be provided with a microscope with:

- Eyepiece lens, ×10 (equal to 16 mm or $\frac{2}{3}$ ")
- Low-power objective lens, x10 (equal to 16 mm or ^{2"})
- High-power objective lens, $\times 40$ (equal to 4 mm or $\frac{1}{6}$ ")
- Eyepiece graticule fitted within the eyepiece and visible in focus at the same time as the specimen.

To avoid confusion, only the lenses specified above should be fitted in the microscopes to be used in the examination. Any lenses which are **not** ×10 or ×40 should be removed or replaced.

Each candidate must have sole, uninterrupted, use of the microscope for at least one hour.

Supervisors are advised to remind candidates that **all** substances in the examination should be treated with caution. Pipette fillers and safety goggles should be used where necessary.

In accordance with the COSHH (Control of Substances Hazardous to Health) Regulations, operative in the UK, a hazard appraisal of the examination has been carried out.

The following codes are used where relevant.


C = corrosive MH = moderate hazard

 $\mathbf{H}\mathbf{H}$ = health hazard \mathbf{T} = acutely toxic

F = flammable O = oxidising

N = hazardous to the aquatic environment





When small test-tubes are provided, it is expected that these are approximately 150 mm in height.

If other dimensions of apparatus are required, these will be specified.

Confidential Instructions

No access to the Question Paper is permitted in advance of the examination.

For both Questions

Each candidate will require:

- ruler, marked in mm (note: for Question 2 this must be a clear plastic ruler)
- clean and dry apparatus, e.g. glassware and syringes (without a needle)
- · solutions supplied in a suitable beaker or container for removal of the solution using a syringe
- fresh solutions, materials and rinsing water where appropriate.

More of the solutions should be available if requested by candidates.

If a candidate breaks any of the apparatus, or loses any of the materials supplied, the matter should be rectified and a note made in the Supervisor's Report.

Solutions should be disposed of in accordance with local safety regulations.

Question 1

Each candidate will require:

10 cm ³ syringes with the means to wash them out	2	
5 cm ³ syringe with the means to wash it out	1	
Beakers or containers, to hold 50 cm ³	5	
Test-tubes – large, to hold more than 25 cm ³ but no more than 50 cm ³ , suitable for heating	7	
Test-tube rack(s) to hold seven large test-tubes or test-tube rack to hold five large test-tubes plus a container to hold two large test-tubes	1	
Test-tube holder to hold hot test-tubes	1	
Bunsen burner, bench mat, gauze and tripod to support water-bath	1	
Beaker (capacity approximately 300 cm ³), with water at 40–45 °C, suitable for heating as a water-bath and labelled hot water . The Supervisor may use a thermostatically controlled water-bath to provide the hot water for candidates.	1	
Thermometer, -10 °C to 110 °C	1	
Container with tap water (capacity approximately 200 cm ³), labelled For washing	1	
Container (capacity approximately 400 cm ³), labelled For waste	1	
Paper towels	8	
Glass marker pen	1	
Stopclock or timer showing seconds	1	
Suitable eye protection	1	

It is advisable to wear suitable eye protection when handling chemicals.

Preparation of materials

(i) R, 1% reducing sugar solution

This is prepared by sprinkling 1.0 g of glucose in 80 cm³ of warm distilled water, stirring and then making up to 100 cm³ with distilled water.

R can be prepared the day before the examination. It should be in a covered container in a refrigerator. **R** should be at room temperature for the examination.

(ii) M1, 10% dried milk solution

This is prepared by dissolving 10 g of dried milk powder in 50 cm³ distilled water, stirring and then making up to 100 cm³ with distilled water. Continue to stir until all of the milk powder has dissolved.

(iii) M2, 0.05% dried milk solution

This is prepared by putting 1 cm³ of **M1** into 99 cm³ of distilled water and stirring well. This makes a 0.1% solution.

50 cm³ of this 0.1% solution should be mixed with 50 cm³ of distilled water to make **M2**. This makes a 0.05% solution.

Question 2

Each candidate will require:

- (i) Clear plastic ruler, marked in mm (see page 3)
- (ii) Slide J1

On receipt of the slides, please check that they are labelled **J1** and that no slides are broken. The material is **confidential** (so **must not** be disclosed to candidates) and the slides should **not** be viewed in advance of the examination.

The number of slides supplied by Cambridge will be equal to half the candidate entry.

Therefore, half the candidates should start on **Question 2** and the other candidates should start on **Question 1**.

(iii) Microscope (as described on page 2)

For each candidate:

- the microscope **must** be set up on low power
- the slide must **not** be left on the stage of the microscope.

SUPERVISOR'S REPORT

The Supervisor's Report is essential in order to allow the Examiners to assess all candidates as fairly as possible and should always be completed by every Centre.

During the examination, the Supervisor or other competent biologist (not the Invigilator), should follow the steps in **Question 1**, in order to obtain results for **1(a)(iii)** and **1(a)(vi)**.

The Supervisor should use the same solutions as those provided to the candidates and work **out of the sight of the candidates**.

These results should be written in the Supervisor's Report, **not** on a spare question paper.

SEATING PLAN

Provide a **seating plan** of work benches, on separate paper, giving details of the places occupied by the candidates for **each question** using each candidate's number.

The Supervisor's Report and the candidates' seating plan should be enclosed with each packet of scripts.

 - (d) any other information that is likely to assist the Examiner, especially if this cannot be discovered from the scripts.
