Examiner rounds any burette readings to the nearest $0.05 \mathrm{~cm}^{3}$, checks subtractions and then selects the 'best titres' using the hierarchy:

- two (or more) accurate identical titres then
- two (or more) accurate titres within $0.05 \mathrm{~cm}^{3}$, then two (or more) accurate titres within $0.10 \mathrm{~cm}^{3}$, etc. These best titres should be used to calculate the mean corrected titre to the nearest $0.01 \mathrm{~cm}^{3}$.
Examiner calculates the difference ( $\mathbf{\delta}$ ) between the mean titres obtained by the candidate and the Supervisor.
Accuracy marks awarded as shown.
