## General information about practical exams

Centres must follow the guidance on science practical exams given in the Cambridge Handbook.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

#### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

#### **During the exam**

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor must perform the experiments and record the results as instructed.
  This must be done out of sight of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

#### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
  - the scripts of the candidates specified on the barcode label provided
  - the supervisor's results relevant to these candidates
  - the supervisor's reports relevant to these candidates
  - seating plans for each practical session, referring to each candidate by candidate number
  - the attendance register.

# Specific information for this practical exam

During the exam, the supervisor (NOT the invigilator) must do the experiments in Questions 1 and 2 and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

### Materials and apparatus for Question 1

Each candidate will require the following materials and apparatus. Labels do **not** need to include concentrations.

- 4g of anhydrous sodium carbonate, Na<sub>2</sub>CO<sub>3</sub>, in a dry stoppered test-tube, labelled solid N
  The anhydrous sodium carbonate should be newly purchased.
- [MH] 6g of hydrated sodium carbonate, Na<sub>2</sub>CO<sub>3</sub>•H<sub>2</sub>O, in a stoppered test-tube, labelled

Washing soda crystals are NOT suitable.

- access to water and at least 100 cm<sup>3</sup> of distilled water
- 50 cm³ measuring cylinder
- 250 cm³ beaker for support
- 2 × polystyrene cups (cardboard cups may be used as an alternative)
- stop-clock or timer which can measure to an accuracy of 1s
- stirring thermometer, -10 °C to 110 °C at 1 °C graduations
- teat pipette
- spatula

During the exam, the supervisor (NOT the invigilator) must do the experiments in Questions 1 and 2 and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

### Materials and apparatus for Question 2

Each candidate will require the following materials and apparatus. Labels do **not** need to include concentrations.

- [C][MH][N] 0.5 g of copper(II) nitrate-3-water, Cu(NO<sub>3</sub>)<sub>2</sub>•3H<sub>2</sub>O, labelled solid P
  - 0.5 g of potassium bromide, KBr, labelled solid Q
  - [MH][N] aqueous silver nitrate of sufficient concentration to give a positive halide test
    - [C] aqueous nitric acid of concentration 1 mol/dm<sup>3</sup>
    - [C] aqueous sodium hydroxide of concentration 1 mol/dm<sup>3</sup>
  - [MH][N] aqueous ammonia of concentration 1 mol/dm<sup>3</sup>
    - small piece of aluminium foil, approximately 1 cm × 1 cm in size
    - distilled water
    - red and blue litmus paper
    - splints
    - 10 cm³ measuring cylinder
    - apparatus for two flame tests
    - Bunsen burner and means to light it
    - rack of test-tubes
    - 2 × boiling tubes
    - stopper to fit test-tubes and boiling tubes
    - test-tube holder
    - teat pipettes
    - spatula
