- (ii) Briefly describe how the Bible is used in church services. [4]
- (b) Explain why the Bible is a source of authority for Christians. [7]
- (c) 'Reading the Bible is more important than going to church.'
Discuss this statement. Give your own opinion and show that you have thought about other points of view. You must refer to Christianity in your answer. [6]

- (ii) Outline the birth story of Jesus. [4]
- (b) Explain the importance of the resurrection of Jesus for Christians. [7]
- (c) 'The Ten Commandments are the most important Christian text.'
Discuss this statement. Give your own opinion and show that you have thought about other points of view. You must refer to Christianity in your answer. [6]

Section B – Islam

If you have chosen this section, answer **all** the questions.

- 3 (a) (i) What is the relationship between the minaret and the adhan (call to prayer)? [3]
- (ii) Briefly describe how Jummah (Friday mid-day) prayers are different from other prayers. [4]
- (b) Explain the significance of the muezzin for Muslims. [7]
- (c) ‘Ordinary people can easily follow the example of the Prophet (pbuh).’
Discuss this statement. Give your own opinion and show that you have thought about other points of view. You must refer to Islam in your answer. [6]

Discuss this statement. Give your own opinion and show that you have thought about other points of view. You must refer to Islam in your answer. [6]

- 5 (a) (i) Give **three** ways in which the Jewish community might use the synagogue. [3]
- (ii) Briefly describe the Sefer Torah (Torah scrolls). [4]
- (b) Explain why the minyan (number required for public worship) is important for Jews. [7]
- (c) ‘Only rabbis need to study the Talmud (commentary).’
Discuss this statement. Give your own opinion and show that you have thought about other points of view. You must refer to Judaism in your answer. [6]
