Instructions for preparing apparatus

These instructions give details of the apparatus required by each candidate for each experiment in this paper. A summary of the questions that will be presented to the candidates is included, where appropriate, to allow the Biology teacher to test the apparatus appropriately. **No access to the question paper is permitted in advance of the examination.**

If a candidate breaks any of the apparatus, or loses any of the material supplied, the matter should be rectified and a note made in the Supervisor's Report.

Candidates must be provided with a microscope with:

- Low-power objective lens, e.g. x 10 (equal to 16 mm or ²/₃")
- High-power objective lens, e.g. \times 40 (equal to 4 mm or $\frac{1}{6}$ ")
- Eyepiece graticule fitted within the eyepiece and visible in focus at the same time as the specimen.

Each candidate must have sole, uninterrupted, use of the microscope for at least 55 minutes.

Supervisors are advised to remind candidates that **all** substances in the examination should be treated with caution. Pipette fillers and safety goggles should be used where necessary.

In accordance with the COSHH (Control of Substances Hazardous to Health) Regulations, operative in the UK, a hazard appraisal of the examination has been carried out.

The following codes are used where relevant.

 \mathbf{C} = corrosive substance \mathbf{F} = highly flammable substance

H = harmful or irritating substance **O** = oxidising substance

T = toxic substance N = harmful to environment

Centres are reminded that they are **not** permitted to open the question paper envelopes before the examination. Confidential Instructions

Each candidate will require

Question 1

Fresh A, W, iodine, S, X and Y are needed for each candidate.

More of the solutions should be available if requested by candidates.

Solutions and reagents provided to the candidates should be supplied in a suitable beaker, or container, for removal of the solution using a syringe.

It is important that the ascorbic acid, **A**, and iodine solution are prepared within one hour of the start of Question 1.

Summary of solutions and reagents

Α	ascorbic acid	[H] irritant	0.1	100
W	distilled water	none	_	100
iodine solution	iodine in potassium iodide	[H] irritant	0.5 g iodine in 1% potassium iodide	40
S	starch suspension	none	0.1	20
X	sample – ascorbic acid	[H] irritant	0.05	20
Y	sample – distilled water	none	-	20

It is advisable to wear safety glasses/goggles when handling chemicals.

Preparation of solutions and reagents

[H] (i) A, at least 100 cm³ of 0.1% ascorbic acid in a covered beaker or container, labelled A. This is prepared by making a 1.0% stock solution by dissolving 1 g of ascorbic acid in 80 cm³ of distilled water in a beaker, make up to 100 cm³ with distilled water and mix well. To make the 0.1% ascorbic acid add 10 cm³ of this stock solution to a beaker, make up to 100 cm³ with distilled water and mix well. This is sufficient quantity for 1 candidate.

(ii) W, at least 100 cm³ of distilled water, in a beaker or container, labelled W.

[H] (iii) lodine, at least 40 cm³ of iodine solution in a small beaker or container, labelled iodine.

The 1% potassium iodide is prepared by dissolving 1g of potassium iodide in 80 cm³ of distilled water in a beaker, make up to 100 cm³ with distilled water.

Then dissolve 0.5 g of iodine in 100 cm³ of 1% potassium iodide.

The iodine needs to be mixed well to make sure that it dissolves.

This is sufficient quantity for 2 candidates.

Please note that this is not the same concentration of iodine solution which is used for the starch test.

(iv) S, at least 20 cm³ of 0.1% starch solution in a small beaker or container, labelled S. This is prepared by making a stock solution of 1% starch solution by dissolving 1 g of starch into a small volume of distilled water and mix to make a paste. Make up to 100 cm³ with hot distilled water. It will be necessary to heat the starch solution to dissolve the starch.

To make the 0.1% starch solution add 10 cm³ of this stock solution to a beaker, make up to 100 cm³ with distilled water and mix well. The starch solution must be at room temperature for the examination.

This is sufficient quantity for 4 to 5 candidates.

[H] (v) X, at least 20 cm³ of 0.05% ascorbic acid in small beaker or container, labelled X. To make the 0.05% ascorbic acid add 10 cm³ of the 0.1% stock solution from (i) to a small beaker and add 10 cm³ of distilled water. This is sufficient quantity for 1 candidate.

(vi) Y, at least 20 cm³ of distilled water in a small beaker or container, labelled Y.

During the examination, the Supervisor should, **out of the sight of the candidates**, carry out **Question 1** using the same solutions and reagents as the candidates. These results should be written in the Supervisor's report which should be enclosed with the candidates' scripts. Please ensure that if the scripts are in several packets that a copy of the Supervisor's report is enclosed with each packet of scripts. The Invigilator should **not** carry out **Question 1**.

Question 2

- (i) Slide L1 (supplied by Cambridge)
- (ii) Microscope with:
 - Low-power objective lens, e.g. x10 (equal to 16 mm or ²/₃)
 - High-power objective lens, e.g. $\times 40$ (equal to 4 mm or $\frac{1}{6}$ ")
 - Eyepiece graticule (supplied by Cambridge) fitted within the eyepiece and visible in focus at the same time as the specimen.

On receipt of the slides, please check that they are labelled **L1** and that all the slides are intact. The identity of material on the slides is **confidential** and must **not** be disclosed to candidates.

Each candidate must have sole, uninterrupted use of the microscope for 55 minutes.

The number of slides supplied by Cambridge will be equal to half the candidate entry. Therefore, half of the candidates should start on **Question 1** and the other half should start on **Question 2**.

RETURN OF EXAMINATION MATERIALS TO CAMBRIDGE

Immediately after the examination the microscope slides must be:

• returned to Cambridge in the containers in which they were received, using the self-adhesive label. They must **not** be included in the package of scripts.

 purchased using the order form enclosed with the slides, which should be completed and returned to Cambridge. They must **not** be included in the package of scripts.
